



## **CALL 076/2014**

Provides for the selection process for admission of Foreigners in undergraduate and occupation of positions available in the second half of 2014, the Universidade do Extremo Sul Catarinense - UNESC.

**UNIVERSIDADE DO EXTREMO SUL CATARINENSE - UNESC** maintained by FUNDAÇÃO EDUCACIONAL DE CRICIÚMA - FUCRI, legal entity of private law, conveys all foreigners who are interested in open enrollment for the Selection Process of Foreigners for entry into undergraduate courses and occupancy of available subjects in the second semester of 2014, the terms and conditions contained in this announcement:

### **1 – SELECTION PROCESS OF FOREIGN**

1.1 The Selection Process for Foreign entry in undergraduate courses and to fill the places available on courses in the second semester of 2014 will meet the terms and conditions of this call.

1.2 This selection process Foreigner's target audience is foreigner' students not resident in Brazil carriers certificate of completion of secondary school or equivalent.

1.3 The Selection Process Foreign intended to fill the places in the first stage of the courses, in accordance with item 3.1.

1.4 The Selection Process vacancies offered by foreign enrollments have their conditional to availability in the first phase or, if filled all vacancies in the first phase, the other phases of the courses, subject to availability of vacancies in the discipline, as well as compliance with the requirements for pursuing them.

### **2 - REGISTRATION**

2.1 Registration will be conducted from March 24<sup>th</sup> to April 30<sup>th</sup>, 2014, the time from 8am to 12pm and from 2pm to 6pm, the Coordination of International Relations (Phone: 55-48 - 3431-2660) located in Room 01 of Block Centac, with campuses in University Avenue, No. 1105 - University Quarter - Criciúma, Santa Catarina, Brazil.

2.2 The registration form, available at the address <http://www.unesc.net/reinternacionais>, should be completed and emailed to the address: [iro@unesc.net](mailto:iro@unesc.net) until the date specified in item 2.1 of this edict.

2.3 Upon submission of the application form, candidates must submit by digital means, the documents listed below, under the present condition of the originals of the same at the time of registration, with appropriate consular authentication of the documents listed in items "b" and "c".

- a) Passport if available or identity card;
- b) Certificate or Diploma Completion of high school;
- c) Transcripts of high school;

2.3.1 The course of secondary education should be recognized in the country of origin and must undergo revalidation in Brazil by the State Board of Education of Santa Catarina (<http://www.cee.sc.gov.br/>) within up to six months after enrollment UNESC.

2.4 The candidate may enroll in only one course, should review and sign the registration form verifying the accuracy of the information contained therein, getting after the signing, entirely responsible for the same.

2.5 The candidate non- Lusophone approved will present at enrollment, Certificate of Proficiency in Portuguese for Foreigners (CELPE - Bras).

3.1.1 UNESC reserves the right not to offer places if the number of candidates per course in college entrance examination is less than the number of places needed training class.

3.2 Will also be offered on the Selection Process of Foreign vacancies in various disciplines offered at all stages.

3.2.1 The list of courses offered will be available at enrollment.

### 4 – THE SELECTION

4.1 The Selection Process of Alien will be conducted by a Selection Committee specific, nominated by the Pro-Dean of Undergraduate Studies of UNESC.

4.2 The selection process will take place by analyzing and scoring the transcript of the applicant's high school, according to the criteria set out in item 4.3 of this announcement.

4.3 For scoring purposes will be considered the average of the grades of Transcript of high school ( Grade 2 ) of the candidate, which will be converted, with up to two decimal places, number of points , without rounding.

4.4 It is entirely up to the Selection Committee to review the documentation submitted, with no recourse for their decisions.

## **5 – CLASSIFICATION**

5.1 Candidates will be ranked with the highest score in descending order.

5.2 Selected candidates will be called for the classification order.

5.3 In the final classification, among candidates with equal number of points, the tiebreaker will be of full age.

5.4 Filled the spaces of the first phase , or chance do not offer the course, candidates will be called for the occupation of vacancies available in other phases of the courses, for which enrollment will be subject to availability of vacancies in disciplines and will depend on compliance with institutional prerequisites required for pursuing them.

5.5 The list of successful candidates will be approved by Act of Pro-Dean of Education, according to a list submitted by the Selection Committee, and published on May 5<sup>th</sup>, 2014, on the site of UNESC.

5.6 The enrollment will take place on July 29<sup>th</sup>, 2014, on the campus of UNESC, according to notice of the registration to be published together with the publication of selected.

## **6 – GENERAL PROVISIONS**

6.1 The registration implies acceptance by the candidate of all the principles, standards and conditions of the Selection Process Abroad, set out in this notice.

6.2 The candidate upon registration statement providing false, inaccurate, or present document adulterated or untrue will have their registration canceled and annulled all acts arising from it.

## **7 - FINAL PROVISIONS**

7.1 After completion of the enrollment of candidates selected under this selection process , as well as under Vestibular ACADE the UNESC reserves the right to publish notice of re-option , aimed at enabling candidates who were not selected for the courses in which enrolled can opt for another course in which there is vague or disciplines available.

7.2 All cases, problems or issues that arise and which are not expressly set forth in this notice will be resolved by the Pro-Dean of Undergraduate Studies.
